

STATEWIDE CODE

- FOLLOW THE LOCAL CODE

STATEWIDE CODE

 CONSIDERING STATEWIDE CODE EFFORTS ARE ALMOST CERTAINLY GOING TO CONTINUE, HOW DO THE REQUIREMENTS AROUND SEPTIC TANK CONSTRUCTION VARY AROUND THE STATE AND HOW MIGHT THOSE DIFFERENCES BE RECONCILED IN A STATE CODE? I.E.

FARM PORTABLES EXEMPTION

• IS THE DEQ WATCHING THE FARM OPERATIONS NOW THAT THEY ARE ABLE TO SERVICE, MOVE PORTABLE RESTROOMS AND SEPTAGE WITHOUT BEING LICENSE THROUGH THE STATE?

FARM PORTABLES EXEMPTION

- NO (SHORT ANSWER)
- IT'S COMPLICATED (THE LONG ANSWER)

 A SEPTAGE HAULER BUSINESS REPRESENTATIVE, WHO ALSO HAPPENS TO HOLD ALL CONTINUING SEPTAGE EDUCATION HOURS FOR HIS BUSINESS, PASSES AWAY UNEXPECTEDLY. HE LEAVES A 10-EMPLOYEE BUSINESS WITHOUT A REPRESENTATIVE WHO HAS ATTAINED CSE HOURS. THE BUSINESS IS TOLD THAT IT MUST SHUT DOWN IMMEDIATELY UNTIL THE MINIMUM REQUIRED CSE HOURS ARE EARNED BY A NEW REPRESENTATIVE. HOWEVER, THE NEXT AVAILABLE SERIES OF APPROVED EDUCATIONAL COURSES IS NOT AVAILABLE FOR ANOTHER SIX MONTHS. WOULD THE DEQ BE WILLING TO WORK WITH A BUSINESS IN THIS SITUATION AND ALLOW IT TO CONTINUE OPERATING, EVEN WITH RESTRICTIONS OR ADDITIONAL REQUIREMENTS, TO PRESERVE THE JOBS OF THE TEN PEOPLE WHO, THROUGH NO FAULT OF THEIR OWN, MAY NOW BE FACING UNEMPLOYMENT?

- THE CSE CREDITS BELONG TO THE BUSINESS, NOT THE RESPONSIBLE AGENT
- THE BUSINESS WILL NEED AN RA WITH 30 CREDITS AT TIME OF RENEWAL

PENALTIES

• WHAT IS THE PENALTY FOR A DISPOSAL FACILITY FOR ALLOWING A HAULER TO BRING IN A 4500 GALLON TRUCK AND DISPOSE AT A 3500 GALLON RATE?





- IF THEY ARE LYING TO SKIRT NPDES PERMIT LIMITS, THEN FELONY AND LOSS OF CERTIFICATION
- IF IT'S ACTUALLY 3,500 GALLONS IN A 4,500 TRUCK, THEN NO HARM, NO FOWL



PENALTIES

- IF CERTIFIED OPERATOR, THEN LOSS OF CERTIFICATION, FELONY, LOSS OF JOB, FINES
- IF NOT CERTIFIED OPERATOR, LOSS OF JOB, FINES

DEQ FEES

• PART 117 IS A LAW

- THE FEES ARE SPECIFIED IN LAW
- ONLY THE LEGISLATURE CAN CHANGE THE FEES

VOLUME RECORDS

• DOES A LICENSED SEPTAGE HAULER NEED TO CARRY VOLUME RECORDS OTHER THAN WHAT HE IS CURRENTLY TRANSPORTING?

VOLUME RECORDS

- NO. YOU ONLY NEED RECORDS FOR THE CURRENT LOAD IN THE TRUCK
- THE COMPLETE VOLUME RECORDS MUST BE RETAINED AT YOUR BUSINESS FOR 5 YEARS

RECEIVING FACILITIES

• I'M BASED IN OAKLAND COUNTY IS THERE ANY OTHER PLACE AVAILABLE FOR ME TO DISPOSE OF MY WASTE? I CURRENTLY DUMP AT THE OAKLAND COUNTY DUMP BUT THE WASTE GOES TO THE CITY OF DETROIT.

RECEIVING FACILITIES

- YOU CAN TAKE SEPTAGE TO ANY RECEIVING FACILITY THAT WILL ACCEPT IT.

UNDERGROUND UTILITIES

- LHDS HAVE RECORDS OF SYSTEM LOCATION AND RESERVE AREA

DOUBLE TANKS

• WHEN IS IT ADVANTAGEOUS TO USE TWO TANKS OVER ONE? DO TWO TANKS DO A BETTER JOB AT DISTRIBUTING WASTE?

DOUBLE TANKS

- IT ALL DEPENDS ON LOCAL CODE
- INTENDED TO PROVIDE MORE RETENTION TIME AND INCREASE SETTLING

TESTING WATER TIGHTNESS

• WATERTIGHT SEPTIC TANKS BEING CRITICAL TO THE LONG TERM PERFORMANCE OF THE WASTEWATER SYSTEM, WHAT ARE THE BEST WAYS OF OBJECTIVELY ASSESSING THE STRUCTURAL INTEGRITY AND "WATERTIGHTNESS" OF A PRE-EXISTING AND IN-USE SEPTIC TANK, ASIDE FROM VACUUM TESTING WHICH IS NOT PRACTICABLE IN MOST SITUATIONS FOR AN EXISTING IN-USE TANK? I WOULD REALLY LIKE TO SEE MSTA COME OUT WITH A RECOMMENDED PROCEDURE.

• WE ALL KNOW ABOUT PFAS CONTAMINATION IN OUR STATE'S GROUNDWATER, AND NOW WE ARE HEARING OF MUNICIPALITIES TESTING THEIR MUNICIPAL WASTEWATER OUTFLOWS AND INFLOWS AND FINDING EXTREMELY HIGH LEVELS IN SOME CASES. WHAT ABOUT BIOSOLIDS THAT HAVE BEEN PRODUCED FROM THOSE SAME MUNICIPAL WASTEWATER TREATMENT PLANTS?
